The Regional Marine Pollution Emergency Response Centre for the Mediterranean Sea (REMPEC) is a Regional Activity Centre established within the framework of the Mediterranean Action Plan of the United Nations Environment Programme (UNEP), with a view to coordinating the activities of the Mediterranean coastal States related to the implementation of the Prevention and Emergency Protocol to the Barcelona Convention for the Protection of the Marine Environment and the Coastal Region of the Mediterranean Sea. The Centre is administered by the International Maritime Organization (IMO) and hosted in Malta by the Maltese Government in terms of a host country agreement signed between the Government of Malta and IMO in 1990.

REMPEC would like to procure the services for simultaneous interpretation services English/French/English for two (2) years from 1 July 2020 to 30 June 2022. - Third Meeting of the Barcelona Convention Offshore Oil and Gas Group (OFOG), 8-9 June, Malta

Please note that interpretation services are usually required for 6 hours working hours on a daily basis, excluding coffee breaks and lunch (i.e. Meeting starting at 9.00 ending at 17.30 with 30min coffee break in the morning and 30 min in the afternoon and a lunch of approximately 1h30). REMPEC cover the cost of lunches for the interpreters during the meeting days.

The following requirements should be included into the quotation:

- Pricing per hour and per day,
- Additional cost such as perdiems, travels, etc...if interpreters are coming from abroad
- CV's of interpreters commonly used by your company,
- References: List of companies/organizations your company has worked for.

All prices are to indicate if VAT is excluded or included.

Interested applicants are requested to address all points raised above when submitting their offer. Additional material and/or brochures/promotional material, may be appended at the end of the submission.

Provided that they have reached REMPEC before the abovementioned deadline, requests will be answered by email and be published

REMPEC will then proceed to select a Company which in its opinion, has the employee skills, the company experience to be able to deliver the most appropriate services against its requirements and subsequently continue rendering a durable high level service to REMPEC, during the tenure of the contracted period.

The REMPEC Procurement Selection Committee will open the bids and proceed with the selection of the most appropriate offer during the second week of May 2020 and will communicate the results in due time.

The Centre will award a two (2) year contract for Interpretation Services to the selected company, with effect from 1 July 2020, with possibility of renewal subject to the agreement of both Parties in writing.
