


Figure 8.1 Schematic diagram of the overall impacts of emissions from the shipping sector on climate change (from Lee et al., 2009a)

# International Convention for the Prevention of Pollution from Ships (MARPOL)

#### **Air Pollution Conference 1997**

- MARPOL: Main international convention covering prevention of operational or accidental pollution of the marine environment by ships
- Air Pollution Conference 1997 adopted new Annex VI "Regulations for the Prevention of Air Pollution from Ships" through adding a Protocol to MARPOL 73/78
- Entered into force May **2005**





### **Regulation 1 - Application**

1. The provisions of this Annex shall apply to all ships, except where expressly provided otherwise in Regulations 3, 5, 6, 13, 15, 16, 18, 19, 20, 21, 22 and 22A of this Annex









### **Regulation 2 – Definitions**

- A large number of terms are defined (more than 50).
- Example terms defined are:
  - Emission Control Area where the adoption of special mandatory measures to control  $NO_x$  or  $SO_x$  ...
  - **Fuel oil** means any fuel delivered to and intended for combustion ..... including gas, distillate and residual fuels.
  - Marine diesel engine means any reciprocating internal combustion engine operating on liquid or dual fuel ... In addition, a gas fuelled engine installed on a ship constructed on or after 1 March 2016 ...



### **Regulation 3 - Exceptions and Exemptions**

- > Regulations of this Annex shall not apply:
  - > When suffering damage to ship or equipment
  - ➢ When saving life at sea
  - When securing safety of ship
  - Ship trials for research
  - Emissions from sea bed activities (for platforms)



#### **Regulation 4 – Equivalents**

- 1. The Administration of a Party may allow any ... apparatus .. or compliance methods <u>used as an alternative</u> if such ... appliances or compliance methods are <u>at least as effective as that required by this Annex</u>, ....
- 2. The Administration of a Party which allows such an alternative ..... shall communicate to the Organization for circulation to the Parties the particulars thereof, for their information and appropriate action ...

#### MARPOL Annex VI

In 1997 a new annex was added to the International Convention for the Prevention of Pollution from Ships (MARPOL). The Regulations for the Prevention of Air Pollution from Ships (Annex VI) seek to minimize airborne emissions from ships (SOx, NOx, ODS, VOC) and their contribution to global air pollution and environmental problems. Annex VI entered into force on 19 May 2005 and a revised Annex VI was adopted in October 2008 which entered into force on 1 Ju 2010.

Administrations are required to make notifications to the Organization under the following regulations of MARPOL Annex VI:

- <u>Regulation 4.2</u>: equivalent compliance method;
- <u>Regulation 11.4</u>: detection of violations and enforcement;
- <u>Regulation 13.7.1</u>: approved methods for certain marine diesel engines installed on a ship constructed prior to 1 January 2000;
- <u>Regulation 15.2</u>: ports or terminals regulating the emissions of Volatile Organic Compounds (VOCs);
- · Regulations 17.2: ports, terminals or ship-breaking facilities where reception facilities are available;
- Regulations 17.3 ; ports, terminals or ship-breaking facilities where reception facilities are alleged to be inadequate;
- <u>Regulation 18.1</u>: fuel oil availability;
- · Regulation 18.2.5: evidence of non-availability of compliant fuel oil;
- · Regulation 18.9.6: failure of fuel oil suppliers to meet the requirements specified in regulation 14 or 18 ofAnnex VI;
- Regulation 19.6: allowance, suspension, withdrawal or declination of application of regulation 19.4 of Annex VI;
- · Regulation 19.6: allowance, suspension, withdrawal or declination of application of regulation 19.4 of Annex VI and;
- <u>Specimens</u> : specimens of certificates.

### MARPOL Annex VI – Chapter 2

#### Survey, Certification and Means of Control



### **Regulation 5 – Surveys and Inspections**

- Every ship of <u>400 gross tonnage or above</u> and every fixed and floating drilling rig and other platforms shall be subject to the surveys specified below:
  - a. an initial survey before the ship is put into service or ...
  - b. A **renewal survey** at intervals specified by the Administration, but not exceeding five years, ....
  - c. An **intermediate survey** within 3 months before or after the second anniversary date or within 3 months before or after the third anniversary date of the certificate....
  - d. An **annual survey** within three months before or after each anniversary date of the certificate...
- Surveys of ships ... shall be carried out by officers of the Administration or RO (Recognised Organisation) .....



### **Regulation 6 – Issue or Endorsement of Certificates**

- 1. An **International Air Pollution Prevention (IAPP) Certificate** shall be issued, after an initial or renewal survey ..., to:
- 2. An International Energy Efficiency (IEE) Certificate shall be issued, after an initial survey....
- 3. A **Statement of Compliance** related to fuel oil consumption .... shall be issued to the ship ....
- 4. All certificates are issued by the Administration or by Ros on their behalf.



#### **Regulation 7 – Issue of a Certificate by another Party**

A Party may, at the request of the Administration, survey a ship and, ...shall issue or authorize the issuance of an IAPP Certificate ...

No IAPP Certificate shall be issued to a ship which is entitled to fly the flag of a <u>State which is not a Party</u>.



### **Regulation 8 – Form of Certificates**

The IAPP Certificate and its Supplement\* shall be drawn up in a form corresponding to the model given in **appendix I** to this Annex ...

#### INTERNATIONAL AIR POLLUTION PREVENTION CERTIFICATE

Issued under the provisions of the Protocol of 1997, as amended by resolution MEPC.176(58) in 2008, to amend the International Convention for the Prevention of Pollution from Ships, 1973, as modified by the Protocol of 1978 related thereto (hereinafter referred to as "the Convention") under the authority of the Government of:

#### **Regulation 9 – Duration and Validity of Certificates**

- An IAPP Certificate shall be issued for a period specified by the Administration, which shall not exceed five years.
  - Renewal details, dates, etc. given ....
- > An IEE Certificate is valid for the life of the ship.
- A Statement of Compliance for fuel oil consumption DCS is valid for one year.



### **Regulation 10 – Port State Control on Operational Requirements**

- <u>A ship, when in a port or an offshore terminal under the jurisdiction of</u> another Party, <u>is subject to inspection by officers duly authorized by</u> such Party ....
- the Party shall take such steps as to ensure that <u>the ship shall not</u> <u>sail</u> until the situation has been brought to order in accordance with the requirements of this Annex.

### Regulation 11 – Detection of Violations and Enforcement

- 1. <u>Parties shall co-operate in the detection of violations</u> and the enforcement of the provisions of this Annex ....
- 2. Any Party shall furnish to the Administration evidence, if any, that the ship has emitted any of the substances in violation of the provisions of this Annex.
- 3. <u>Upon receiving such evidence</u>, the Administration shall investigate the matter ..... and when sufficient evidence is available ..., it shall act against the ship in accordance with its law as soon as possible.
