**IMPLEMENTATION OF THE SAFEMED PROJECT**

**Note by the Secretariat**

**Background**

1. During the 7<sup>th</sup> and 8<sup>th</sup> Meetings of Focal Points of REMPEC, the Secretariat had provided information on the implementation of the three year European Union (EU) financed MEDA<sup>1</sup> regional project entitled "EUROMED COOPERATION ON MARITIME SAFETY AND PREVENTION OF POLLUTION FROM SHIPS - SAFEMED", which is being implemented by REMPEC in ten Euromed Mediterranean partners<sup>2</sup> namely, Algeria, Egypt, Israel, Jordan, Lebanon, Morocco, Palestinian Authority, Syria, Tunisia and Turkey, and which commenced on the 1 January 2006.

2. It should be recalled that the SAFEMED Project is a response to the interest of the EU to develop Euro-Mediterranean co-operation in the field of maritime safety and security and prevention of pollution from ships by providing technical advice and support to the non-EU Mediterranean partners identified in the 1995 Barcelona Process. The main objective is to mitigate the existing imbalance in the application of maritime legislation in the region between the EU and non-EU Mediterranean partners, through promoting a coherent, effective and uniform implementation of the relevant international conventions and rules aimed at better protecting the marine environment in the Mediterranean region by preventing pollution from ships.

3. The operational implementation phase of the SAFEMED Project was originally scheduled to end on the 31 December 2008. However, the implementation phase was officially extended up to the end of April 2009 mainly to enable the European Commission (EC) and the Project team to organise, in 2009, the 5<sup>th</sup> Meeting of the Maritime Safety Sub-Group of the Euromed Transport Forum Maritime Transport Working Group (which also acts as the SAFEMED Project Advisory Committee) as well as to enable REMPEC to finalise and conclude the implementation of the last few remaining project tasks.

The programme offers technical and financial support measures to accompany the reform of economic and social structures in the Mediterranean Partners.

<sup>2</sup> Refers to the "Mediterranean Partners" as defined in the 1995 Euro-Mediterranean Partnership (Barcelona Process) and constitutes a wide framework of political, economic and social relations between the Member States of the European Union and Partners of the Southern Mediterranean.

### **Implementation of SAFEMED Project Activities**

4. The SAFEMED Project aimed to achieve its objectives through the implementation of specific tasks in five separate, yet deeply interconnected, areas of activity, namely, flag State implementation, safety of navigation, protection of the marine environment, human element, and security of ships and port facilities. The project tasks strived to transfer knowledge in all its aspects through needs assessment missions, elaboration of studies, provision of direct technical assistance, development of recommendations and guidelines, and capacity building including *inter alia* training. Whilst the framework of international maritime conventions and the specific obligations thereunder provided the basis for the action, the Project aimed to assist the beneficiaries meet their commitments by helping to identify bottlenecks in the implementation of these conventions, and then help develop the required capacity to overcome the problem areas.

5. During the implementation of the SAFEMED Project, REMPEC was technically supported by the International Maritime Organization (IMO), the European Commission (EC), and the European Maritime Safety Agency (EMSA). IMO also provided administrative support and carried out the general oversight of project implementation.

6. With a view to facilitating project implementation, at the time of initiating the implementation of the activities of the SAFEMED Project, REMPEC had requested the project beneficiaries to nominate national contact points to serve as the main channels of communication with regard to the Project and to act as the principal contact point during the experts' missions in the beneficiaries. The national contact points also represented the beneficiaries on the Euromed Transport Forum Maritime Safety Sub-Group/SAFEMED Project Advisory Committee. Nevertheless, the REMPEC Prevention Focal Points and, in certain instances, also the other REMPEC Focal Points, were, as much as possible, kept informed of developments regarding the implementation of the project.

7. Most of the activities of the SAFEMED Project are within the scope of some of the specific objectives of the Regional Strategy for Prevention of and Response to Marine Pollution from Ships, and taking this into consideration, when possible, a number of project tasks have been extended to other Contracting Parties to the Barcelona Convention which are not benefiting from the Project. Moreover, these Contracting Parties also benefited indirectly from several studies and guidelines commissioned within the framework of the Project and which are of interest to all Mediterranean coastal States.

8. During the implementation of the SAFEMED Project, field missions were carried out in the Project beneficiaries to assist the beneficiaries assess their needs and priorities in order to update their national legislation, strengthen their administrative and technical set up and improve compliance with international maritime conventions. The needs assessment missions covered the following aspects: flag State Administrations, Vessel Traffic Management Information Systems (VTMIS), MARPOL Convention Annex I, IMDG Code, ISM Code, and ISPS Code.

9. Within the framework of the SAFEMED Project, the following Studies, Guidelines and Procedures were prepared to assist the beneficiaries in the implementation of international maritime conventions:

- Guidelines and procedures to facilitate the decision making in the Designation of Places of Refuge;
- Guidelines and procedures on the safe removal and final disposal of Anti-Fouling Waste;
- Study on Models for Flag State Administrations;
- Framework for the adequate monitoring of Classification Societies;
- Guidelines on the ratification of MARPOL Annex VI and on the preparations required to submit an application to IMO for the designation of the Mediterranean Sea as a SOX Emission Control Area;
- Study on Possible Sources of Financing for Port Reception Facilities and Vessel Traffic Monitoring Information Systems;
- Study on Maritime Traffic Flows in the Mediterranean Sea.

10. Seventeen students from eight SAFEMED Project beneficiaries were awarded long-term scholarships financed by the Project to follow postgraduate courses at the IMO International Maritime Law Institute (IMLI) in Malta and at the World Maritime University (WMU) in Malmo, Sweden. Moreover, a large number of Government officials from the beneficiaries and sometimes also from

other Contracting Parties to the Barcelona Convention have participated in the following capacity building activities organised within the framework of the Project:

- Short Course on Casualty Investigation;
- Workshop on the Voluntary IMO Member State Audit Scheme;
- Short course on Flag State Implementation;
- Vessel Traffic Management Information System Information Day;
- Training Course for VTS Operators / Managers;
- Workshop on Places of Refuge;
- International Seminar of Initiation to Oil Pollution Response (INFOPOL);
- Seminar on the International Convention on the Control of Harmful Anti-Fouling Systems on Ships, 2001, (AFS Convention);
- Training Course on the Bunkers Convention, 2001;
- Seminar on the Human Element Influence on Maritime Accidents.

11. With a view to ensuring the visibility of the Project and the dissemination of information, a dedicated SAFEMED Project website [www.safemedproject.org] was created. This enabled the project beneficiaries and all interested users to be kept updated on the activities of the project and to download project reports and documents. In view of the follow up SAFEMED II Project referred to hereunder, action is being taken to reconstruct the Project's website so as to allow more interactivity and an easier retrieval of content. The new website is expected to be on line in May 2009.

12. At the time of writing the present document, the SAFEMED Project implementation was almost entirely completed and when the Project is concluded it is anticipated that all the tasks of the Project will have been implemented successfully. A status report on the activities implemented during the period January 2006 - February 2009 is set out in the Annex to the present document.

### **Follow up SAFEMED II Project**

13. In view of the achievements of the SAFEMED Project, now referred to as the "SAFEMED I Project", the European Commission and the Mediterranean partners agreed on the idea to launch a second EU-financed MEDA regional SAFEMED Project (SAFEMED II). As was the case for SAFEMED I, the SAFEMED II Project, which is also a three year project, will be implemented by REMPEC between 2009 and 2011.

14. Building upon the work carried out through SAFEMED I, the SAFEMED II Project should assist the Mediterranean partners with the further implementation of the relevant maritime transport related actions of the Regional Transport Action Plan (RTAP) for the Mediterranean 2007-2013 adopted in 2007 within the framework of the Euromed Transport Forum. Supported by the Project team and the project expertise, the SAFEMED II Project will enable the Mediterranean partners to make further progress on these actions in the Road-Map.

15. Being a follow up project to the original Project, the main and specific objectives of the SAFEMED II Project are the same as those of the SAFEMED I Project. The SAFEMED II Project will encompass the following main activities: flag State implementation, port State control, Vessel Traffic Management Information Systems and related services, protection of the marine environment, and security of ships and port facilities. The project will also include other awareness, visibility, and supporting activities. A Summary of the Technical Annex of the SAFEMED II Project can be found in document REMPEC/WG.INF.6.

16. As was the case for the SAFEMED I Project, in view of the fact that most of the SAFEMED II Project activities are closely linked to some of the specific objectives of the Regional Strategy for Prevention of and Response to Marine Pollution from Ships, REMPEC has included some of the activities of the SAFEMED II Project in the proposed programme of work of the Centre for the biennium 2010-2011 (REMPEC/WG.30/10). This is being done in order to ensure a certain synergy with the activities of REMPEC as well as to ensure the participation of those Contracting Parties not benefiting from the Project in SAFEMED II activities.

**The Meeting of Focal Points is invited to** take note of the information provided and to take it into consideration during the deliberations on Agenda Item 10 (Proposed programme of REMPEC activities for biennium 2010-2011) as well as to comment as deemed appropriate.

This also applied to Egypt and Turkey which benefitted from EU Twinning Projects on Maritime Safety. The SAFEMED Project financed the participation of the Resident Twinning Advisors at the 4<sup>th</sup> Meeting of the Euromed Transport Forum Maritime Safety Sub Group which also acts as the Project's Advisory Committee. Regular contact with EC DG TREN officials also facilitates co-ordination with ongoing and future EU-funded maritime transport related projects. During 2008, the SAFEMED Project team closely followed developments related to the Union of the Mediterranean (UfM) initiative.</p>

8.1 O	Input to the SAFEMED Project follow-up	<p><b>Ongoing:</b> Input regarding the follow-up of the SAFEMED Project is provided during the Euromed Transport Forum meetings and during the Forum's Maritime Safety Sub-group meetings. Moreover, input is provided to the EC as and when requested. A bilateral meeting between the EC (AidCo and DG TREN) and the SAFEMED Project team was held in Brussels on the 1 December 2008 to review the Project's progress and discuss it's follow-up through the implementation of SAFEMED II.</p> <p>At the request of the EC's DG AidCo, in July 2007, three short-term experts were recruited to carry out preparatory work (including the preparation of the Technical Annex and budget) for a follow up SAFEMED II Project. The current SAFEMED Project team prepared the terms of reference for these three short-term experts and co-ordinated their work. The reports of the three experts were forwarded to the EC in October 2007.</p> <p>Following further preparatory work, a contract for the SAFEMED II Project was concluded and signed in December 2007 between the EC and IMO (on behalf of REMPEC). In order to take into account the consolidated results of the SAFEMED Project, as agreed, a review of the SAFEMED II Technical Annex's provisionally agreed tasks and Budget breakdown was carried out in the first half of 2008 and was submitted for the consideration of the EC in June 2008. A final clean text of the Technical Annex was subsequently also agreed upon. An addendum to the SAFEMED II Project contract containing the Project's revised Technical Annex and budget was signed in December 2008.</p>

### General Comments on Project Implementation

Overall, the Project has been largely implemented according to schedule. Almost all the Project's tasks have been successfully implemented. Short training sessions were generally a success, acting as a forum to provide and exchange information. Long-term training courses are attractive and very useful. However, not all the beneficiaries took full advantage of these courses and beneficiaries need to plan well in advance in order to nominate their officials to follow these long-term courses. In this regard, the lack of qualified personnel within the Administrations and insufficient knowledge of the English language have been a stumbling block. Regarding needs assessment missions and desk studies, there was generally good cooperation from the project beneficiaries. The choice of short-term experts was restricted by the project's standard consultancy rates. The situation in the region was a factor which affected the full implementation of the Project for some beneficiaries. Moreover, the security situation in certain beneficiaries caused delays in completing certain tasks and also eliminated the possibility of organising Project activities, such as seminars/workshops, in these beneficiaries.
