Background

- The Protocol for the Protection of the Mediterranean Sea against pollution resulting from exploration and exploitation of the continental shelf and the seabed and its subsoil (Offshore Protocol) was adopted in October 1994, and since its adoption significant regulatory, scientific and technical developments related to offshore activities have been achieved at both regional and global levels.
- The Mediterranean Offshore Action Plan (MOAP) in the framework of the Protocol for the Protection of the Mediterranean Sea against Pollution resulting from Exploration and Exploitation of the Continental Shelf and the Seabed and its Subsoil which was adopted by the Nineteenth Ordinary Meeting of the Contracting Parties to the Barcelona Convention and its Protocols (Athens, Greece, 9-12 February 2016), requests, under Specific Objective 7.c, Contracting Parties to identify the required modifications of Annex I, II and III to the Offshore Protocol and the definition of which chemicals should be covered and not covered by such standards and under which conditions.
- In response to Specific Objective 7.c of the MOAP document UNEP(DEPI)/MED WG.434/3 'List of pollutants' was presented in April 2017 to the First Meeting of the Barcelona Convention Offshore Oil and Gas Group (OFOG) Sub-Group on Environmental Impact. Subsequently, this list was refined in 2018 based on key findings drawn from a consultation process held in line with the conclusions and recommendations of the kick-off meeting which took place in Malta, 21-22 August 2017. The results of this update were presented in UNEP/MED WG. 476/Inf.4 "Rationale for the Guidelines for the Conduct of Environmental Impact Assessment (EIA)".
- In parallel, the Secretariat undertook a thorough analysis of the Annexes to all the pollution-related Protocols, including the Offshore Protocol, which was presented as information document (UNEP(DEPI)/MED WG.439/Inf.14) to the MED POL Focal Points Meeting (Rome, Italy, 29-31 May 2017). This analysis resulted in the identification of additional possible revisions to the Annexes III, IV and VII to the Offshore Protocol.
- The outcomes of the different review processes were consolidated in an initial list of possible amendments to the Annexes of the Offshore Protocol (UNEP/MED WG.476/7) and presented at the Second Meeting of the Barcelona Convention OFOG Sub-Group on Environmental Impact held in Greece, 27-28 June 2019. Further work was completed leading to the adoption of amendments to the Annexes to the Protocol by the 22nd Meeting of the Contracting Parties to the Convention for the Protection of the Marine Environment and the Coastal Region of the Mediterranean and its Protocols (Antalya, Turkey, 7-10 December 2021; COP22) (IG.25/7).

<u>Intersessional Correspondence Group on the Technical review of the Annexes to the Offshore</u> Protocol

- In accordance with the OFOG's Terms of Reference¹ to keep under review the technical content of the Annexes to the Protocol, and make relevant recommendations, and following the adoption of the Programme of Work (PoW) for the biennium 2022-2023 by COP22, REMPEC, facilitated the launch of an Intersessional Correspondence Groups (ICG), of the Barcelona Convention Offshore Oil and Gas Group (OFOG) Sub-Group on Environmental Impact, on the technical review of the Annexes to the Offshore Protocol, identifying further required alignments with international, regional and national standards. The ICG on the technical review of the Annexes to the Offshore Protocol was launched towards the end of 2022.
- 7 The scope of work for the Terms of Reference (ToR) of the ICG on the technical review of the Annexes to the Offshore Protocol includes:

- .1 Keeping under review the technical content of the Annexes to the Offshore Protocol and making relevant recommendations for their periodic update as necessary in accordance with Specific Objective 7 .c Identification of the required modifications of Annex I, II and III and definition of which chemicals should be covered and not covered by such standards and under which conditions of the MOAP (Decision IG.22/3); and
- .2 Building on the working document UNEP/MED WG.498/4 presented at the Third OFOG on Environmental Impact, 3-4 June 2021 and references therein, including links to the Common Standards and Guidance on the Disposal of Oil and Oily Mixtures and the Use and Disposal of Drilling Fluids and Cuttings (Decision IG.24/9 Annex I) and to also take into account recent and ongoing relevant activities and processes at the international, regional and national level.
- 8 The objectives of the ToR included the technical review of the Annexes to the Offshore Protocol, identifying further required alignments with international, regional and national standards and to propose recommendations for modifications and corresponding justification as appropriate.
- 9 Comments and recommendations on the amendments to the Annexes of the Offshore Protocol were received by the Secretariat from a CP to the Offshore Protocol, a Non-Contracting Party to the Offshore Protocol and an accredited MAP Partner.
- Table A1 as set out in Annex I of the present document, attempts to summarize the main elements of the comments and recommendations for easy reference whilst the detailed comments and recommendations received, are compiled in the Meeting Information document REMPEC/WG.55/INF.6.
- One recommendation was the establishment of an ICG to further the work on the revision of the Annexes to the Offshore Protocol.
- In this context, draft ToRs including a timetable prepared by the Secretariat, are set out at Annex II for perusal by the Meeting.

Actions requested by the Meeting

13 The Meeting is invited to:

- .1 take note of the information provided; and
- approve the establishment of an Intersessional Correspondence Group, including its Terms of Reference as set out at Annex II, to further the work on the Annexes to the Offshore Protocol.

Annex II

Proposed Terms of Reference for an Intersessional Correspondence Group (ICG) to work on a revised version of the Annexes to the Offshore Protocol consistent with the Common Standards approved at COP 21

Scope of work

- The scope of work of the ICG on the revision of the Annexes to the Offshore Protocol (in short ICG Revision of Annexes) is to keep under review the technical content of the Annexes to the Protocol for the Protection of the Mediterranean Sea against Pollution Resulting from Exploration and Exploitation of the Continental Shelf and the Seabed and its Subsoil (the Offshore Protocol) and make relevant recommendations for their periodic update as necessary. This is in accordance with the Terms of Reference of the Barcelona Convention Offshore Oil and Gas Group (OFOG) and Specific Objective 7.c Identification of the required modifications of Annex I, II and III and definition of which chemicals should be covered and not covered by such standards and under which conditions of the Mediterranean Offshore Action Plan (Decision IG.22/3).
- This work will build on the working document UNEP/MED WG.498/4 presented at the third OFOG meeting held remotely on 3-4 June 2021, and references therein, including links to the Common Standards and Guidance on the Disposal of Oil and Oily Mixtures and the Use and Disposal of Drilling Fluids and Cuttings (Decision IG.24/9 Annex I). It will also build on the working document REMPEC/WG.55/4 presented at the fourth OFOG meeting on 23-24 May 2023. Furthermore it will take into account the planned activities of the OFOG related to guidelines on the use and discharge of harmful or noxious substances, as well as recent and ongoing relevant activities and processes at the international, regional and national level.

Objectives

- The objective of the ICG Revision of Annexes is to carry out the following tasks with the support of REMPEC:
 - .1 Technical review of the Annexes to the Offshore Protocol, identifying further required alignments with international, regional and national standards;
 - .2 Propose recommendations for modifications and corresponding justification;
 - .3 Submit proposed amendments to OFOG members, partners and experts for consultation:
 - .4 Present outcomes at the fifth OFOG meeting to be held in Q2 2025.

Participation

4 Participation is open to all Contracting Parties to the Barcelona Convention, partner organizations and appropriate entities which can provide the necessary expertise on a timely basis or which have a particular interest in the issue under consideration. Any Contracting Party, partner organization or appropriate entity can join in the work of the ICG Revision of the Annexes and any contribution should be accepted at any stage of the work of the Group.

Organisation of work

- The group will be convened by the Secretariat, with the participation of other CPs, partners and experts (ICG members), and support from the Secretariat (REMPEC).
- 6 The Secretariat is expected to plan, organize and coordinate the work, making sure the task is progressing as planned.
- 7 The Secretariat will correspond remotely, through scheduling of regular remote meetings with the members, as considered necessary.
- 8 The working language is preferably English. Correspondence and documents would also be accepted in French, however no translation will be made by the Secretariat.

Responsibilities

- 9 Responsibilities of the Secretariat include:
 - organization of the work, planning, coordination and keeping track of the progress,
 - .2 establishment of deadlines for the preparation of the recommendations,
 - .3 scheduling regular remote meetings with the members, as considered necessary,
 - .4 facilitation of the administrative and operational functioning of the ICG, including establishment of contacts with other entities etc., as required, and
 - .5 presentation of the recommendations for amendments at the 5th OFOG meeting.
- 11 Responsibilities of the member Contracting Parties include:
 - .1 designation of a person/entity with the corresponding expertise for the issues dealt within the ICG Revision of the Annexes,
 - .2 active participation and contribution to the work of the ICG notably by:
 - a) conducting the technical analysis required for the revision of the Annexes,
 - b) submitting recommendations and justification for the proposed amendment to the Annexes to the Offshore Protocol,
 - .3 compliance with the timeline and deadlines established by the Secretariat, and
 - .4 submit input using the template shared by the Secretariat.
- Responsibilities of third parties participating in the ICG Revision of the Annexes include:
 - .1 active contribution to the technical content of the work of the ICG notably by:
 - a) conducting the technical analysis required for the review of the Annexes,
 - b) submitting recommendations and justification for the proposed amendment to the Annexes to the Offshore Protocol,
 - .2 compliance with the timeline and deadlines established by the Secretariat, and
 - .3 submit input using the template shared by the Secretariat.
