Note by the Secretariat

Introduction

- The Sixteenth Meeting of the Focal Points of the Regional Marine Pollution Emergency Response Centre for the Mediterranean Sea (REMPEC), hereinafter referred to as the Meeting, is being convened in Sliema, Malta from 13 to 15 May 2025, pursuant to the Programme of Work (PoW) and Budget for 2024-2025 of the Mediterranean Action Plan (MAP) of the United Nations Environment Programme (UNEP), also referred to as UNEP/MAP, adopted by the Twenty-third Ordinary Meeting of the Contracting Parties to the Convention for the Protection of the Marine Environment and the Coastal Region of the Mediterranean ("the Barcelona Convention") and its Protocols (COP 23) (Portorož, Slovenia, 5-8 December 2023).
- 2 The principal objectives of the Meeting are:
 - .1 to examine the implementation of the activities and deliverables by REMPEC pursuant to the approved UNEP/MAP PoWs and Budgets for the biennia 2022-2023 and 2024-2025, since the Fifteenth Meeting of the Focal Points of REMPEC (Malta, 13-15 June 2023); and
 - .2 to discuss and agree upon the activities and deliverables of the draft UNEP/MAP PoW for the biennium 2026-2027, as proposed by REMPEC, prior to their submission, for approval by the next meeting of the UNEP/MAP Focal Points (Athens, Greece, 16-19 September 2025), and for adoption by the Twenty-fourth Ordinary Meeting of the Contracting Parties to the Barcelona Convention and its Protocols (COP 24) (Egypt, 2-5 December 2025).
- All REMPEC Governmental Focal Points were invited to nominate, jointly and in consultation with their respective REMPEC Prevention Focal Points and REMPEC OPRC Focal Points, their representatives at the Meeting. The participation of observers representing the oil, chemical, port and shipping industries in national delegations was strongly encouraged. The invitation to attend the Meeting was also extended to the specialised agencies of the United Nations, other governmental and non-governmental organisations, as well as to the international professional organisations and associations, the activities of which are relevant to the work of the Centre.
- In order to assist the Meeting in its work, the following annotations to the provisional agenda provide information on the actions the Meeting will be invited to take under each agenda item.

Opening of the Meeting

5 The Meeting will open on Tuesday, 13 May 2025 at 0900 hours and is expected to close on Thursday, 15 May 2025 at 1700 hours.

Organisation of the Meeting

Rules of Procedure

The Rules of procedure for Meetings and Conferences of the Contracting Parties to the Convention for the Protection of the Mediterranean Sea against Pollution and its related Protocols (UNEP/IG.43/6, Annex XI) shall apply *mutatis mutandis* to the deliberations of this Meeting.

Election of Officers

7 **The Meeting will be invited** to elect a Chairperson, a Vice-Chairperson, and a Rapporteur.

Working Languages

8 The working languages of the Meeting will be English and French. Simultaneous English/French/English interpretation services will be provided during the Meeting. All working documents will be available in both official languages of the Centre, i.e. in English and in French. Information documents will be available in their original language.

9 For reasons of economy, documents referred to during the Meeting which have already been issued for any other REMPEC meeting will **not** be reissued. Delegations are requested to bring their own copies of such documents.

Agenda Item 2: Progress Report on REMPEC activities since the Fifteenth Meeting of the Focal Points of REMPEC

- 11 The Secretariat will introduce document REMPEC/WG.61/2 setting out an outline of the activities carried out by the Centre since the Fifteenth Meeting of the Focal Points of REMPEC (Malta, 13-15 June 2023).
- 12 **The Meeting will be invited** to take note of the information provided and comment, as deemed appropriate.

Agenda Item 3: Developments within MAP related to the objectives and functions of REMPEC

- Under this agenda item, the representative of the UNEP/MAP-Barcelona Convention Secretariat will present information on the developments within UNEP/MAP since the Fifteenth Meeting of the Focal Points of REMPEC. Reference will be made to the main decisions adopted at COP 23 (Portorož, Slovenia, 5-8 December 2023), which are of relevance to the work of the Centre. The Meeting will also be provided with a summary of the recent meetings of bodies of the UNEP/MAP-Barcelona Convention system, the main international and regional meetings and processes of UNEP/MAP relevance, as well as the progress in relation to projects and activities during the current reporting period. Information will be shared on the preparations for COP 24 (Egypt, 2-5 December 2025), as well as the process in enhancing cooperation and partnership with relevant stakeholders.
- 14 **The Meeting will be invited** to take note of the information provided as well as to comment as deemed appropriate.

Agenda Item 4: Developments within IMO related to the objectives and functions of REMPEC

The representative of the International Maritime Organization (IMO) will introduce document REMPEC/WG.61/4, which provides a summary of the latest developments within the IMO in the fields of prevention of, preparedness for and response to marine pollution from ships. In particular, will address the recent activities of the IMO related to the protection of the marine environment with special reference to the activities of the Marine Environment Protection Committee (MEPC) and the IMO's

Sub-Committee on Pollution Prevention and Response (PPR). Reference will also be made to Document REMPEC/WG.61/INF.21, highlighting the recent activities and projects currently implemented by IMO and through IMO's Integrated Technical Cooperation Programme (ITCP) concerning the protection of the marine environment.

- The representative of the International Oil Pollution Compensation Funds (IOPC Funds) will present document REMPEC/WG.61/4/1 providing information on the latest developments in the field of compensation for ship-source pollution damage and the work of the IOPC Funds since the last Meeting of the Focal Points of REMPEC. He will highlight to the Mediterranean coastal States, the implications of those recent developments and of the decisions of the IOPC Funds' governing bodies as well as resulting output of the Organisation during that period. He will also address cooperation arrangements, relevant insurance and HNS issues, and will introduce the online claims submission system, promotional material as well as new publications.
- 17 **The Meeting will be invited** to take note of the information provided as well as to comment as deemed appropriate.

Agenda Item 5: Implementation of the Mediterranean Strategy (2022-2031)

- Under this agenda item, the Secretariat will introduce document REMPEC/WG.61/5, which outlines the progress made with the implementation of the Mediterranean Strategy (2022-2031) and presents the outcome of the Second Coordination Meeting on the Implementation of the Mediterranean Strategy (2022-2031), hereinafter referred to as the Second Coordination Meeting, held in Malta on 21 November 2024. In its presentation, the Secretariat will refer to the Report of the Second Coordination Meeting (Malta, 21 November 2024), as set out in the Appendix to document REMPEC/WG.61/INF.20.
- 19 **The Meeting will be invited** to take note of the information provided and consider the proposals put forward by the Secretariat.
- 20 EMSA will introduce document REMPEC/WG.61/INF.22 providing an overview of the content of the second edition of the European Maritime Transport Environmental Report (EMTER 2025) and document REMPEC/WG.61/INF.23 providing information about the results from the NAVISON Project, a Project aiming at quantifying underwater radiated noise in the Seas around Europe, led by EMSA.
- The Secretariat will also introduce document REMPEC/WG.61/5/1, which provides the Draft Guidance Document on the Preparation of National Action Plans for the Implementation of the Mediterranean Strategy for the Prevention of, Preparedness, and Response to Marine Pollution from Ships (2022-2031), as approved by the Second Coordination Meeting (Malta, 21 November 2024). - Finally, the Meeting will be requested to consider document REMPEC/WG.61/5/2, which proposes the development of a Policy Framework on Gender and Youth Mainstreaming within the Context of the Mediterranean Strategy 2022-2031. This framework should aim to ensure that gender and youth considerations are integrated into all aspects of the Strategy, promoting equality, inclusivity and empowerment throughout the Mediterranean region. This was already discussed and approved by the Second Coordination Meeting (Malta, 21 November 2024).

- Maritime Traffic and Offshore Oil and Gas Activities Trends and Outlook
- Under this agenda item, the Secretariat will introduce document REMPEC/WG.61/6, which deals with **Maritime Traffic and Offshore Oil and Gas Activities Trends and Outlook** and presents the Draft Terms of Reference for the Update and Upgrade of the Study on Maritime Traffic and Offshore Oil and Gas Activities Trends and Outlook (December 2021).
- The **Meeting will be invited** to take note of the information provided, consider the proposals put forward by the Secretariat in document REMPEC/WG.61/6, as well as examine and endorse the Draft Terms of Reference for the Update and Upgrade of the Study on Maritime Traffic and Offshore Oil and Gas Activities Trends and Outlook, as set out in the Annex thereto.
- Marine Pollution Monitoring: Results of the Survey on Needs of Capacity Building on the use of IMAP CI
- The Secretariat will introduce document REMPEC/WG.61/6/1, which provides an update on Marine Pollution Monitoring: Results of the Survey on Needs of Capacity Building on the use of IMAP CI, in accordance with and the conclusions and recommendation of the regional Workshop on Reporting, Monitoring and Data Sharing, Malta, September 2024 (MEDEXPOL 2024), as laid down in the Report of the Workshop provided in document REMPEC/WG.61/INF.5. In particular the Secretariat will refer to the connection of the synthesis of the results to the thresholds for oil spills and acute pollution, and the management of HNS spills provided in document REMPEC/WG.61/6/1.
- The Meeting will be invited to take note of the information provided, consider the proposals put forward by the Secretariat in document REMPEC/WG.61/6.
- Marine Pollution Reporting: Lowering the threshold of Oil Spill Reporting
- The Secretariat will introduce document REMPEC/WG.61/6/2 concerning Marine Pollution Reporting: Lowering the threshold of Oil Spill Reporting and provide an overview of the information provided by the consulted institutions for lowering the minimum threshold for reporting (on oil spills), taking into consideration the work of other regional sea conventions, as well as the MSFD. In particular the Secretariat will highlight the conclusions of the consultation and the way forward.
- 29 **The Meeting will be invited** to take note of the information provided in document REMPEC/WG.61/6/2, comment as deemed appropriate, and endorse actions provided in paragraphs 45 and 46 of the document REMPEC/WG.61/6/2.
- Marine Pollution Reporting: Common Emergency Communication System for the Mediterranean
- The Secretariat will introduce document REMPEC/WG.61/6/3 on Marine Pollution Reporting: Common Emergency Communication System for the Mediterranean, providing elements facilitating decisions on the way forward for the use of CECIS MP as the Common Emergency Communication System for the Mediterranean, in parallel with the commencement of the new CECIS MP development. The Secretariat will present the process for the operation of the new System, as introduced during MEDEXPOL 2024, considering the outcomes of the 14th Meeting of the Focal Points of REMPEC (May 2021) and launched, in January 2025, through the established of the CECIS MP 2.0 User Working Group, by the European Commission's DGECHO to coordinate the development of the application and its defined modules; User management, Emergency, Request for Assistance, Resources.

The Secretariat, being a member of the Working Group, will make recommendations on the contribution and involvement of the Contracting Parties, in this process either directly or through the Mediterranean Technical Working Group, highlighting relevant distinction between EU Member States and Third Parties.

31 **The Meeting will be invited** to take note of the information provided in the document REMPEC/WG.61/6/3, comment as deemed appropriate, discuss and agree on the involvement of the Contracting Parties in this process.

• Update of Guidelines and Tools

- The Secretariat will introduce document REMPEC/WG.61/6/4, **Update of Guidelines and Tools**, and provide a proposal for reviewing and updating of the manuals and guidelines developed by REMPEC, as well as their development, or parts thereof, to electronic versions.
- 33 **The Meeting will be invited** to take note of the information provided in the document and to comment and agree upon the list of the guidelines to be updated and/or digitalised, as provided in the Annex to the document.
- Review of the Guidelines for the use of dispersants for combating oil pollution at sea in the Mediterranean region
- The Secretariat will introduce document REMPEC/WG.61/6/4/1 Review of the Guidelines for the use of dispersants for combating oil pollution at sea in the Mediterranean region. The Secretariat will clarify that the review concerned the Part II Basic Information on Dispersants and their Application of the Guidelines to reflect the specific characteristics of the Mediterranean and incorporate the latest developments on dispersants since 2011. The revised version of the Guidance Document is included as **Annex** to the document.
- 35 **The meeting will be invited** to take note of the information provided in the document REMPEC/WG.61/6/4/1, and to examine and approve the revised Guidance Document.

Upgrading of Databases and REMPEC Platforms

- The Secretariat will introduce document REMPEC/WG.61/6/4/2 on **Upgrading of Databases** and **REMPEC Platforms**, and present the tools, listed in the Annex to the document, as well as recommendations from the 15th Meeting of the Focal Points and MEDEXPOL 2024, aimed at the consolidation of MEDGIS-MAR to prevent functionality Gaps, and to ensure links to common topics and deliverables with the Country Profile and BCRS. The Secretariat will also address the revision of MIDSIS-TROCS 4.0 to prevent duplication with MEDGIS-MAR regarding HNS pollution incidents. The Secretariat will make a proposal for a new Country Profile structure to enhance its practicality for reporting, exchange of information, and improve the visibility of national actions and activities. This includes the possibility to upload national references, such as national reports, as well as templates of reports and manuals such as the manual on national mechanism for the mobilisation of responses equipment and personnel in case of emergency, provided in document REMPEC/WG.61/INF.6.
- 37 **The meeting will be invited** to take note of the information provided in the document REMPEC/WG.61/6/4/1, and to comment and agree on the upgrade the use of MEDGIS-MAR and the Country Profile.
- Mediterranean Technical Working Group (MTWG) and related activities
- The Secretariat will introduce document REMPEC/WG.61/6/5, **Mediterranean Technical Working Group (MTWG) and related activities**, and provide an update on the progress made by the

- The Secretariat will highlight key developments, including the endorsement of the Adriatic Marine Pollution Incident Contingency Plan (2023), the long preparatory work for the Joint Spills Responses Exercise (CypEx 2024) and subsequent Guidelines on Joint Spill Response Exercises within the Sub-Regional Contingency Plan (2025), outlined in document REMPEC/WG.61/6/7/1. The Secretariat will also present the new IMO International Operational Guide on the Response to Spills of HNS (2024), provided in document REMPEC/WG.61/INF.8. This guide being developed on the basis of the HNS Manual Multi- Regional Bonn Agreement, HELCOM and REMPEC (2021).
- Guidance Document on Joint Spill Response Exercise within the Sub-regional Contingency Plans
- The Secretariat will than introduce document REMPEC/WG.61/6/7/1, providing the **Guidance Document on Joint Spill Response Exercise within the Sub-regional Contingency Plans,** and present an overview of the context that led to the development of the Guidance Document. The outcome of the webinar for its review and the recommendation for its approval.
- 45 **The meeting will be invited to** take note of the information provided in the document REMPEC/WG.61/6/7/1, to agree on strengthening sub-regional cooperation through joint exercises and encourage Contracting Parties to utilize the HNS Manual and to examine and approve the revised Guidance Document as set out in the Annex thereto.

- The Meeting will be invited to take note of the information provided and consider the proposals put forward by the Secretariat in document REMPEC/WG.61/7, as well as examine and endorse the Draft Guidance Document on the consistent implementation of the 0.10% sulphur limit under MARPOL Annex VI in the Med SO_X ECA, as set out in the Appendix 1 thereto.
- The Secretariat will introduce document REMPEC/WG.61/7/1 on the Study on the Environmental and Legal Impacts of the Use of Exhaust Gas Cleaning Systems (EGCS) in the Mediterranean Sea. In its presentation, the Secretariat will refer to the Study, as set out in the Appendix to document REMPEC/WG.61/INF.11.
- The Meeting will be invited to take note of the information provided as well as to comment, as deemed appropriate.
- Under this agenda, the Secretariat will also provide an update on the preparation of a detailed Technical and Feasibility Study to assess the relevant existing and on-going studies as well as to examine the possible designation of the Mediterranean Sea, as a whole, as an Emission Control Area for Nitrogen Oxides (Med NO_X ECA) pursuant to MARPOL Annex VI, including health and socioeconomic impacts on the Mediterranean region and the individual Contracting Parties.

The Meeting will be invited to take note of the information provided and consider the proposals put forward by the Secretariat in document REMPEC/WG.61/7, as well as examine and endorse the Tentative Detailed Work Plan and Timetable for the work of the NECA TCE, as set out in the Appendix 2 thereto.

Agenda Item 8: Reduction of GHG emissions from ships

- The Secretariat will present the various Studies undertaken by the REMPEC during the 2023-2024 biennium relating to the Reduction of GHG emissions from ships.
